473 villages have been earmarked by the state under Ganga Action Plan with a mission to make them Open Defecation Free. The target for achieving ODF status in these villages is 31st December, 2016. It was agreed upon by the Development Partners in the review meeting of Ganga Action Plan held on 15th November, 2016 with OSD, MDWS, to provide additional support to the districts under Ganga Action Plan for speedy implementation of program in the earmarked villages.

Accordingly, with the consent of development partners, the allocation of districts to the development partners has been done along with the common agreed upon roles and responsibilities. The document detailing the same has been attached. It is requested to go ahead with the proposed activities in the allocated districts and start the work at the earliest to achieve the GAP targets.
