Lohiya Swachh Bihar Abhiyan is organizing 3-days residential Capacity Building training programme for Block Development Officers (BDOs) on implementation of LSBA. The purpose of this training is to enhance the capacity of Block level functionaries in implementation of Lobiya Swachh Bihar Abhiyan (SBM G+LSY). The selection of the DOs for training will be from the blocks having low sanitation coverage.

- 3. Vehicle arrangement for field visit and CLTS demonstration.
- 4. Selection of panchayats and Villages for field CLTS training.
- 5. Identification of "Local Champions" including field functionaries. Panchayat Sevak, IAY Sahayak, Block Coordinators, BDO, BPM, DC. or Motivators for demonstration and role model activities.
