Dear *Sh. Balamurugan,*

As you are aware, Deptt. of Social Justice and Empowerment, Government of India with the support of NITI Aayog has initiated National Survey of Manual Scavengers for which National Safai Karamcharis Finance and Development Corporation (NSKFDC) is nodal agency. The survey teams in each district consist of representatives of local bodies(both rural and urban) to be nominated by the District Collector and representative of NSKFDC taken from the NGOs.

2. In your State, 16 districts have been identified for the survey. However, survey camps for 15 districts are yet to be scheduled.

3. You will appreciate that the survey work was to be completed by 30th April, 2018 in terms of directive issued by the Niti Aayog and the Ministry of Social Justice and Empowerment. However, the progress of the survey has been tardy in your State.

4. Accordingly, you are requested to please issue appropriate instructions to the concerned State and District Nodal officers to expedite the holding of survey camps with the involvement of the District Coordinators already nominated by NSKFDC as its representatives, and direct the concerned District Nodal Officers to forward the District Survey Reports to NSKFDC along with the survey forms at the earliest possible for further action at our end.
