

Sir/Madam.

With reference to the letter BRLPS-LSBA/Proj/20/17/507 dated 01st Dec 2017, an extensive survey was conducted by districts in the months of December 2017 and January 2018. Upon survey, as reported by districts, it was found that these dysfunctional toilets can be categorized in 4 categories as mentioned in the below table. In continuation of the LSBA Letter No: - BRLPS-LSBA/Proj/20/17/261 dated 04th July 2018, please find the updated streamlined process of converting dysfunctional toilets: -

Continuation of the State Action on Dysfunctional Toilets

Dear Sir / Madam.

This is in continuation of the letter NO – 16011/4/2018-SBM, for State action requested on dysfunctional toilets. Under the SBM (G) definition, dysfunctional toilets are non-usable and/or unsafe toilets, constructed during Central Rural Sanitation Programme (CRSP), Total Sanitation Campaign (TSC), Nirmal Bharat Abhiyan (NBA). To streamline the process of converting dysfunctional toilets to functional, following actions have been taken -

- State can record, into IMIS, the physical conversion of dysfunctional toilets using C-08 module (as is the current practice).
- Deletion of Dysfunctional toilets and shifting into suspense account All the deleted dysfunctional toilets (Approximate 6.5 lakh) have been shifted in suspense account and States may record reasons for the earlier deletion in module B17. The reasons can be -
 - Household does not exist but paid
 - Household does not exist and not paid
- For the remaining dysfunctional toilets, where household does not exist, States can shift them into the suspense account through B03 module and provide appropriate reason -
 - Household does not exist but paid
 - Household does not exist and not paid
- The entries marked paid as in point 4 and 5 above, should match with the earlier Utilization Certificates.
- Overall dysfunctional reports can be viewed in ER108 using State and District level credentials.
- The utilization of Swachh Bharat Kosh and World Bank funds for conversion of dysfunctional toilets will be monitored
